CHAPTER 15

The First Three Generations

#13 **Josiah Perry-3** b. 28 Nov. 1684 at Watertown, Mass., eighteen years after his father and grandfather had arrived in the New World, having left behind them in London, the old life in settled ways. He was the seventh child and fourth son (the second to live) of John Perry-2 (#4) (John-1) and his wife Sarah Clary. He became a weaver, like his predecessors, and was similarly industrious and frugal—some would call him parsimonious. Josiah Perry and Bethia Cutter were mar. 12 Jan. 1708, Watertown, Mass. She was b. 2 Dec. 1686, Cambridge, Mass., dau. of Ephraim Cutter and Bethia Wood. Ephraim was a son of the immigrant Richard Cutter, whose descendants became connected through marriage with a large number of New England's oldest and best known families, including many connections with the Perry family (see Chap. 4). They had ten children, all born at Watertown.

Shortly after the Peace of Aix-la-Chapelle, which seemed to promise a cessation of hostilities between the French and English in New England, during the intermittent "French and Indian Wars," there came a call to the towns in eastern Mass., then already becoming populous, for recruits and additions to what we now call "the heart of the commonwealth," namely, the town of Worcester. Worcester had many times been baptized in blood. Its first and second settlements had been entirely broken up by Indians in the French interest. Its first permanent occupation was made in 1713, and five years later the struggling hamlet was doubled in population and otherwise strengthened by a colony of Scotch-Irish, direct from Ulster, come at the invitation and encouragement of Governor Shute of Mass. In "Lovell's War," that soon followed, and in the "Old French War" of 1744-48, the people of Worcester had borne a full share. La Chapelle, a lull rather than a peace, provided time for a considerable movement westward.

The Perry family had found a home in Watertown and Cambridge on the banks of the Charles River for nearly ninety years when Josiah Perry (then sixty-six years of age) and his son Nathan (born in 1718,

the very year the Scotch-Irish had settled in Worcester) heard and answered the call for settlers. In 1751 they, like Josiah's father and grandfather before him, went to a new land, in what is now central Mass. The original farm of eighty acres was purchased from Elijah Hedge, deed being dated 15 Apr. 1751; it was located on "Sagatabscot Hill" (the Indian name), the site now known as Vernon Street, Union Hill. It was held jointly in the names of Josiah and Nathan Perry, which fact may have tended to make the family more influential than it otherwise would have been. The land was near the northwestern slope of the hill just west of the original lot of Digory Sargeant, who settled there and tried to maintain his footing after every other settler had gone away, even after the Boston authorities had urged him to go. He was killed by the Indians, his wife tomahawked, and his five children carried to Canada, in 1704. Sargeant was buried by Capt. Howe of Marlboro, and twelve armed men, at the foot of an oak tree on the northern point of Sagatabscot Hill. Settling as the Perrys did so near the stirring events and traditions of the town, these must have left a deep impression on their lives, especially of the younger ones.

The Perry homestead, though rebuilt and enlarged several times, remained on the original 1751 site down through the years, owned and occupied by successive Perry generations until its sale following the death in 1902 of Joseph Stone Perry, great-grandson of Nathan. Subsequent purchases of additional acres enlarged the original farm; its value was also increased by the development of the town. The entire town of Worcester became a city in 1848; even ordinary farming lands became much more valuable under the municipality; and such a farm as this was, on high land commanding a view of all the main streets of the city, and in the vicinity of the College of the Holy Cross, and other public institutions, became in the course of time one of the most highly valued properties in the town. In later years, a little at a time, it was subdivided among the different heirs in the family line, so that by the beginning of the twentieth century Vernon St. on Union Hill was lined for half a mile or more by substantial homes, most of them owned and occupied by different Perry families. During the following fifty years the situation was changed; death and removals have left those homes to others, stranger to the name of Perry, until now there are few descendants of Josiah Perry resident in Worcester.

Bethia, wife of Josiah Perry, died in Watertown, Mass. 9 Oct. 1735, sixteen years before the beginning of the Worcester adventure. Josiah, then in his 52nd year, mar. Elizabeth, widow of Jonathon Harrington*, 10 Mar. 1736, prob. at Watertown. She was b. 3 Aug. 1687, Watertown, dau. of Joshua Bigelow and Elizabeth Flagg. She died at Watertown 26 Sept. 1748. His third mar. was to Sarah Stowell 17 Oct. 1749. She went

with him to Worcester and died there 1 Feb. 1754. Josiah lived to be nearly 83 yrs. old and died 17 Sept. 1767, at Worcester.

The Holbrook, Leland, and Morse families were closely connected with this Perry family (descendants of Josiah) and with the John Perry of Roxbury family (see chap. 24). Abigail Leland's sister Ruth mar. Samuel Perry who was 1st cousin of Daniel Perry, brother-in-law of our Ephraim Perry. Abel Perry, son of Samuel Perry and Ruth Leland, mar. Keziah Morse, prob. cousin of Martha Morse, wife of Jonathon Perry.

Ephraim and Mary Perry resided in Sherborn, Mass. until after 1751, since it is known their first four children were born there; their place of residence following that time is unknown, except that he was living in Medfield, Mass. 6 Jan. 1781 when he petitioned the State of Mass. for reimbursement of expenses paid by him, for the burial of his son Wilder, a member of the State Marines. This letter is recorded page 219, Mass. Archives. The dates and place of the deaths of Ephraim and Mary are unknown.

She was b. 29 Sept. 1727, Watertown, dau. Deacon Thomas Fiske and Mary Pierce. Their first three children b. in Watertown, before the removal of Nathan and his father Josiah to Worcester, Mass. as related in the section on Josiah Perry-3 above.

Nathan was a weaver, like his progenitors; he became a deacon in his Church, like his son and grandson in succession. From the first he devoted himself assiduously to his loom, his farm, his church duties, and his civic responsibilities. Well-authenticated traditions made his manners somewhat gruff and otherwise eccentric; he showed the narrow spirit of an old guildman, as is proven by the fact that he was wont to be disturbed considerably if any one else set up the weaving business in Worcester, or if any person there learned any other branch of weaving than the common kind practiced as a matter of course by all the good housewives.

In civic affairs Nathan Perry was very prominent in the town and county of Worcester, especially after the bold stand he took in 1775 in favor of armed resistance to the Crown, when many of the wealthiest and most influential citizens of the town became Loyalists, and some of them went into voluntary exile. The farmer and weaver of Sabatabscot Hill, then fifty-seven years old, drew the confidence of his patriotic fellow-citizens to a remarkable degree. He was chosen treasurer of the county of Worcester in the opening year of the Revolution, and filled that position until 1790—15 yrs. During 13 of those years he was also treasurer of the town. For 9 yrs. before 1789 he was a member of the Board of Selectmen, and Chairman of the Board 6 of those yrs.

He was very strict in his observance of the Sabbath, which, then, began on Saturday night. He frequently took down the sermons in shorthand. He became Deacon of the Old South Church in 1783 and continued in that office continuously until his death in 1806, 23 yrs. in all. His son Moses was Deacon for 35 yrs. in the same church and for 6 yrs. in Union Church (successor to Old South); his grandson Samuel held the same office in Union Church for 35 yrs., making a total period of 99 years for the three generations of the Perry family in the deaconate.

The name of Nathan Perry appears often in the town records of Worcester. In 1761 he is called "Constable Perry," and also "Warden Nathan Perry." A list of those drawn as jurors dated 4 Jan. 1757, contains the name of Nathan Perry. In March 1760 his name was on the list of Assessors, Surveyors, Collectors of Taxes, and of Selectmen. On 26 May 1769 it was voted that James Goodwin, Jacob Chamberlain, and Nathan

Perry be a committee to settle accounts with the Town Treasurer (previous to his own appointment). Again in 1768, 1769 he was named surveyor and collector of taxes, and on a committee to provide a schoolmaster. In 1770 he was elected to sit in the Elder's seat to assist others seated there in leading "ye congregation in singing." On completion of Old South Church and the sale of the choice of pews, March 1764, he had the 40th choice and took pew number ten. He was chosen Moderator of Town Meeting several times. In 1779 he was named to a committee of three to make proper provision for the families of non-commissioned officers and soldiers serving for that town in the Continental Army, agreeable to the resolves of the Court. In a record dated 1775 he was called Lt. Nathan Perry, who was called to assess damages for laying out a road. In 1773 he built a fence around the burying ground, and was agent with Wm. Young to fix the lines and boundaries of the parish to be formed from Leicester, portions of Worcester and Sutton. 12 March, 1781, Josiah Perry and James Barber were chosen tythingmen; 28 Apr. 1783, "We, the subscribers, have met and perambulated the line between Worcester and Ward."—signed Nathan Perry, Josiah Perry. Auburn was formerly called Ward. In March 1777 Nathan, with seven others, was chosen "Overseer of the Poor." Many other entries showing Nathan Perry's name appear in the Town Records.

At one time there was in possession of the family a book, an old religious work, written by Henry Gibbs, A.M., pastor of the First Church of Christ in Watertown, and printed in 1721 in Boston. Josiah probably bought the book since the Rev. Gibbs was pastor of his Church. The lids were wooden covered with leather. On the flyleaf in front was written: "Josiah Perry—His Book." Lower down on the same leaf appears: "Nathan Perry—His Book, Given him by his father in ye year 1750." On the flyleaf at the back of the book was kept the family record. The first record was "March ye third, 1670."

The names of the children of Alice and Reuben Ammidown have not yet been discovered; however, it is known that Mrs. Rees Rickards of Blackinton, Mass. was a granddaughter.

John Perry left Mass. about 1674, when he was 25 yrs. of age, and settled at what was later known as Crabtree's Point, a part of North Haven, in the Fox Islands which are in the Penobscot Bay on the southern, or Atlantic, coast of Maine. He also took land between Perry's Creek and Seal Cove, on the south Island, Vinalhaven. During the Revolution he was one of those who suffered much from foraging parties while Castine, Me. was in the hands of the British. Family traditions say that he was stoutly hated by the English because, when his neighbors all wished to take a neutral position during the War, he firmly refused to do so, though he should lose all he had. This attitude is similar to that maintained by his cousin Nathan Perry (6711). The British burned his house and carried off all his goods. He then went to what is now Rockland Highlands and built a new home. A party of British and Tories seeking him there found him not at home, since he was forewarned, and so burned this place. He then petitioned the Governor and the Council of the Commonwealth of Mass. for a commission to operate a boat which he had procured and named the Fly, for the sole purpose of interrupting the trade between the inhabitants (Tories) and the enemy. The commission was granted to Capt. John Perry 21 Aug. 1781 (Mass. Archives, Vol. 171, page 465.) He was successful in driving the British out of that section of Maine.

When and where he and Lucy Wooster were mar. is uncertain, but there is little doubt that it was subsequent to his removal to Maine. Lucy d. in Dec. 1832 and Capt. John mar. (2) the widow of William Perry (supposedly unrelated to John's family). This must have been after he was 83 yrs. old. Date of his death is unrecorded.

and settled at Quinsigamond* and from him the Quinsigamond Perrys are descended.

(It is remarkable that Hannah had eight sons before the birth of her only daughter.) Hannah was descended from Rev. Edward Hall who came to America and settled in Duxbury, Mass. 1636, Edward's son John was the father of Nehemiah. She was also descended from many other first-comers, and from those prominent in the affairs of the colonies. The family was remarkable for its longevity, for its individualism and for its active patriotism. Her father and grandfather, as well as numerous brothers, uncles and cousins, served in the Revolutionaary Army as well as taking parts in the struggle known as the French and Indian Wars.

Moses Perry inherited the farm as well as the ancestral occupation of weaver. These were years of civic strife in Worcester and throughout the country. Industry was injured and the schools broken up. Moses had but six weeks of schooling annually, yet he was an intelligent person

*The original Plantation of Quinsigamond, founded in 1668, later was renamed Worcester; then the area about Lake Quinsigamond (4 mi. long) on its eastern limits was referred to by that name.

and became a far-seeing man of affairs. He was frugal, industrious, prosperous, esteemed by community and church. Though of a somewhat placid nature, he had great force of character. He was Deacon in Old South Church for 35 yrs.

After Hannah and Moses were married, his parents resided in the same home until their deaths at the ages of 94 and 87. When Samuel Perry, fourth son of Moses, who was to inherit the farm, married, he brought his bride to the old home. Such was the character of this three-generation home, since there was an interval of only 10 years between the death of Moses' mother and of Moses' son Samuel, in 1823, the same year the new house was built.

Moses d. at Worcester 12 Mar. 1842; Hannah survived him by 19 yrs., the date of her death being 26 Nov. 1861, at Worcester. In his will, probated 3 May 1842, Moses stipulated in detail and at the same length, his bequests to Hannah and the portions of the house which were to be reserved for her exclusive use "so long as she shall remain my widow, . . . , but not to dispose of the same to any person whatever." While Samuel was named an inheritor of the farm and home, and sole executor of the estate, Moses made generous bequests to all his other children and grandchildren then living, in his will.

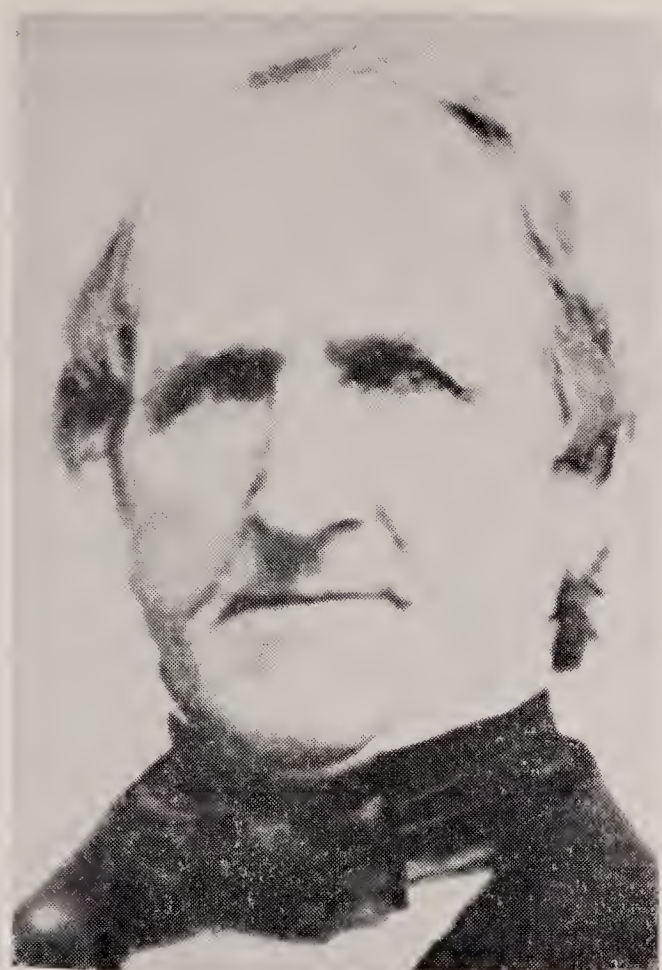
