

## THE EARLIEST SHERMANS OF DEDHAM, ESSEX, AND THEIR WIVES

PART 2: HENRY SHERMAN THE YOUNGER AND HIS WIFE

Henry Sherman the younger married Susan Lawrence in Moze, a parish in northeast Essex overlooking the Walton Backwaters, on 14 June 1568, a fact that has been known since it was reported in the *Register* in 1913. <sup>[79]</sup> The Moze parish registers begin in 1548, but the only other Lawrence entries there, until at least 1678, are the baptisms of Ann Lawrence (21 May 1548), Jane Lawrence (26 August 1549), and Thomas Lawrence (21 May 1551), all described as children of "Jhon" Lawrence. <sup>[80]</sup>

Mrs. Stratton tried to find further clues by consulting Morant's *History of Essex*, <sup>[81]</sup> but more relevant and rewarding sources are the Dedham manor court rolls:

Dedham Hall, Monday, 26 September 17. Eliz (1575). James Lawrence and Joan his wife, late wife of William Thorpe, surrendered seven acres of land called Skultons to the lord, who regranted the same to Joan for the term of her life, and after her death to William Thorpe. [82]

Dedham Hall, Monday, in the last week of Quadragesima, 16 April 18 Eliz. (1576). Joan late wife of James Lawrence and previously wife of William Thorpe, who held one cottage and seven acres of land . . . died since the last court [12 October 1575]. Rose Havelocke the late wife of Thomas Havelocke was the only daughter and heir of William Thorpe. Rose Havelocke is the only daughter and heir of Rose and Thomas Havelocke, and is aged 8 years. Custody of the body and tenements of Rose was granted to Barbara Lawrence with her assent. [83]

December 1583 contumaciously and outside the court surrendered by the hands of Thomas Lawrence instead of the bailiff... one piece of meadow called Greylands Meadow containing seven acres now in the tenure of Thomas Woodnutt or his assigns, to the use and behoof of Henry Sherman and his heirs, upon condition that if William do pay Henry Sherman £30 at Christmas Day 1589 then the surrender shall be void and of no effect. [84]

Dedham Hall, First Court of William Glover, Monday the last (30) of April 35 Eliz. (1593). William Acton of Ipswich, Clothier, on 30 December [1592] surrendered, in the present of Henry Sherman and Thomas Glover, all his houses and lands held in this Manor and of the Manor of Overhall and Netherhall in Dedham to the use and behoof of James Lawrence son of John Lawrence of Fressingfield, Suffolk Gent and his heirs and assigns, upon condition that if James pay to William Acton £70 and £50 [on specified dates] at the Cornhill Cross in Ipswich, then the surrender shall be of full effect, whereupon James Lawrence prayed to be admitted to seven acres of land in the Hallfield, one cottage with half and acres of land called the Forge, one acre of land, two parcels of Chesehouse land and herbage, and one pond of the demesne called the Netherpond, one messuage upon Churchgate Row, one parcel of demesne, parcel of Chesehousefield, 22 acres of land in the Hallfield, one close called Longversland, one acres of meadow called Long Acre, taken 3 August 1592. Dedham Hall, Thursday in Easter week, namely 4 April 36 Eliz. (1594). James Laurence since the last court surrendered, in the presence of Henry Sherman and Edmund Sherman, all his houses and lands and tenements held of this Manor to the use and behoof of Thomas Lawrence son of John Lawrence of Fressingfield, Suffolk, Gent, who came by Henry Sherman his attorney and prayed to be admitted [to all the lands described on 30 April 1593, as above]. [86]

Dedham Hall, Thursday after St Michael the Archangel, 2 October 37 Eliz. (1595). Thomas Laurence Gent on 4 November 1594 surrendered . . . all his lands [described on 30 April 1593, as above] to the use and behoof of Edmund Cotton esquire and his heirs . . . which Thomas had taken to himself and his heirs at a Court General held here on Thursday in Easter week 4 April 1594 by the surrender of James Lawrence. [87]

The court rolls of the Manor of Overhall & Netherhall on 4 April 1594 and 2 October 1595 record similar transactions, but without describing the lands held of that manor. [88] However, the second entry describes Edmund Cotton as of Barton Magna in Suffolk.

Thomas T. Sherman reported that in Easter term 1600 Joan Carter, widow and administratrix of the goods of John Carter deceased sued Thomas Lawrence of

Easthorpe [Essex] and Henry Sherman of Dedham clothier for £20 each. [89] In his will dated 21 August 1610, proved 8 September 1610, [90] Henry Sherman gave "unto my brother Lawrence of Easthorpe my best cloak." [91]

These facts lead us to the family of Lawrence of Fressingfield and South Elmham, Suffolk, the earliest part of which needs more original work than I have been able to do. However, I have been assisted by the three-box "Lawrence Collection" at the Society of Genealogists, which in several notebooks contains notes on families with that surname throughout England. [92]

The first Lawrence to be associated with Fressingfield seems to have been John Lawrence of "Mendham alias Fressingfield," "husbandman alias yeoman," who on 6 November 1507 at Westminster received a pardon for his outlawry in the counties of Suffolk and Norfolk for not appearing before the king when indicted with others of divers trespasses and rescues; he having surrendered to the Marshalsea before the king, as John Fyneux, knight, Chief Justice of Pleas before the king, has certified in the Chancery. [93]

Thomas Lawrence was one of many tenants in Ipswich of lands formerly held by the late Priory of Holy Trinity, Ipswich, that were granted on 21 March 1544/5 to Sir Thomas Pope. [94] It is not known whether this man was related to the South Elmham family. However, there was an earlier Thomas Lawrence, whose will dated 17 July 1471, shows he had lands at Rumburgh, South Elmham, and elsewhere in Suffolk. This Thomas could have been the uncle of John of 1507, but not, I think, his father because Thomas' own son John was of Rumburgh, leaving a will dated 10 July 1504. The father of Thomas Lawrence, the 1471 testator, was John Lawrence (died 1461), who heads the pedigree of Lawrence of Rumburgh, Suffolk. [95]

We move on to firmer ground with the pedigree recorded by the antiquary Thomas Tanner, Bishop of St. Asaph (1674–1735). [96] He may have obtained the details from a member of the family. I myself have not seen the notebook in which he entered it, [97] but the copies made independently by the Suffolk historian Joseph James Muskett [98] and the compiler of the "Lawrence Collection" agree. [99] The pedigree is headed by \_\_\_\_\_\_ Lawrence, a famous preacher, a reverend grave minister who had been a preacher to those who fleeing from religion in Q. Marie's day [1553–58] met together in woods & secret places, as they could. He was a gentleman of a great estate & exceeding liberality to the poor. In the time of Q. Elizabeth he preached at Fressingfield. He owned St James Park in South Elmham.

The first name of this preacher was John. Tanner attributed to him five children, but when Muskett constructed the pedigree of this family, he gave the preacher just one child, his son John (died 1610/1), to whom Muskett attributed nine children. This number included the five children of the preacher as named by Tanner, but he [Muskett] bracketed Margaret, wife of Richard Elmye, to show doubt about her place, as she was not named in a charter dated 2 February 1604/5, recited in the inquisition post mortem dated 3 August 1613. [100] Tanner and Muskett knew nothing about the Moze and Dedham records cited above, so, taking them and other records into account, I construct the pedigree as follows, which I have extended to show that some Fiske, Mason, and Peck settlers in New England were also Lawrence descendants. [101]

1. \_\_\_\_ LAWRENCE had at least two sons, order of birth unknown, the postulated dates being conjectures:

2. i. JOHN LAWRENCE, b. say 1500, the "reverend grave minister," m. at least once.

ii. JAMES LAWRENCE, b. say 1505, of Dedham yeoman; m. (1) probably ca. 1545 JOAN (\_\_\_\_\_) THORPE, widow of William Thorpe of Dedham, who d. by 6 Nov. 1544. Joan was bur. Dedham 3 Jan. 1575/6, and James m. (2) BARBARA \_\_\_\_\_, who was appointed guardian of William Thorpe's [only] granddaughter, Rose Havelocke, in 1576.

2. JOHN LAWRENCE (1.i) was born say 1500. He was a preacher, the "grave reverend minister" described above. He may have married a relative of John Burward of Debach, Suffolk, who in his will dated 12 April 1572, left his lands in three parishes to the preacher's son John. On 13 November 1587 at Westminster there was a Pardon of Alienation for John Lawrence of Southelmham, to whom by will 12 July 1574 [sic] the late John Burward bequeathed his lands in Bredfield, Bouze, and Hacheston, co. Suffolk, for 6s. 8d. paid to the Queen's farmer. [102] However, the records at the Society of Genealogists assembled by a modern researcher of Burwards and Burwoods [103] do not show an obvious relationship or explain the bequest.

Unless there were several children who died in infancy, the long interval between the birth of John Lawrence's son John and those of his other children is best explained by supposing the preacher had two wives. The postulated birth dates for the children are deduced from their marriages and/or the spans of their children's baptisms.

Children of John Lawrence, order of birth uncertain:

- **3. JOHN LAWRENCE** (2.i), of Fressingfield, Suffolk, gent., was born say 1525. He died 2 January 8 James (1610/1), and was buried in Fressingfield 3 January 1610/1. He married first, say in 1547, **ANNE SAMMES**, born say 1530, buried at St. James, South Elmham, Suffolk, 24 August 1580. He married second **ALICE (VESEY) GUNVILE**, born say 1538, buried in Fressingfield 22 May 1590.

She was the daughter of Thomas and Elizabeth (Gardner) Vesey, [107] and the widow of Henry Gunvile of Manor Barons in Gorleston, Suffolk, whom she had married in 1562. [108] He married third in Dedham, Essex, 17 February 1591/2, as her fourth husband, MARY (COKER) (GARRINGTON) (TURNER) PELLETT, daughter of John Coker, and widow successively of \_\_\_\_\_ Garrington, Thomas Turner, and Richard Pellett. The evidence for her marriages will be set out fully in a future installment.

In 1556 Roger Wyncoll bought land in Rayleigh, Rawreth, and Great Hockley, Essex, from John Lawrence and his wife Anne, Gilbert Hylls and his wife Agnes, Richard Sammes, and William Sammes for £250. [109] The two wives were clearly sisters of the Sammes brothers. They were named before marriage in the will of Alice Sammes of Great Totham, Essex, possibly their aunt, dated 15 October 1546. [110]

John Lawrence acquired land in Fressingfield in 1582, and bought from Michael Wentworth the lordship of the manor of Fressingfield Hall in 1589, which in his lifetime John gave to his son James.<sup>[111]</sup>

John Lawrence was a plausible preacher, but not so good a man as his father. His father gave him St. James Parke in Elmham, after sold to Alderman Massam, who left it to Sir Wm Massam and he to his sonne, whose heire is now owner of it 1660.<sup>[112]</sup>

The surviving children of John Lawrence's first marriage are identified, with the surnames only of the married daughters, in a charter dated 2 February 2 James (1604/5) that is cited in the inquisition post mortem held on 3 August 11 & 46 James (1613), which is given in the Appendix below.

The will of John Lawrence of Fressingfield, gent., dated 18 September 1609, was proved 11 January 1610/1 in the Consistory Court of Norwich, mentioning only his youngest son Nathaniel, as follows:<sup>[114]</sup>

Unto Nathaniel Lawrence my son all my lands and tenements in Fressingfield, being freehold, to him and his heirs of his body lawfully begotten and to be begotten. And for want of such issue then to remain to all my children and their heirs forever. Unto the said Nathaniel Lawrence my son all my lease lands and tenements in Fressing-

field and all my right title interest and term of years which I have of and in the same. All the rest and residue of my goods and chattels I bequeath to him Nathaniel my son, whom I ordain to be the sole executor of this my last will and testament.

The will was witnessed by Henry Barker, Willm Sandwyste, and Robert Gyrlinge.

**4. ALICE LAWRENCE** (2.ii) was born say 1538, and was buried in Dedham, Essex, 7 April 1613. She married about 1561 **WILLIAM GARRARD**, born say 1530, died after 16 February 1600/1 (date of will), son of Robert and Agnes (Merchant) Garrard of Dedham. The will of William Garrard the elder, of Lawford, Essex, was dated 16 February 1600/1 (no date of probate), naming wife Alice; brothers-in-law Thomas Lawrence and Henry Sherman; and his four children shown below as his youngest.

Children of William and Alice (Lawrence) Garrard:

- ROBERT GARRARD, bp. Dedham 12 Sept. 1562; d. probably before this father, unmarried.
- MARGARET GARRARD, bp. Dedham 2 Feb. 1564/5; mother of Barbara, base child, bp. Dedham 9 May 1596.

Thomas Alabaster's will, dated 16 June 1591, mentions unnamed children of daughter Priscilla Lawrence, deceased (late wife of Thomas Lawrence) to receive £10 each at age 21. [125] The will also mentions daughter Anne Still, wife of Dr. Still, and her six children (named) were each to receive £10 each at age 21. Dr. Still was Rt. Rev. John Still, Bishop of Bath and Wells (ca. 1544–1607/8), [126] and he and Anne Alabaster were the maternal grandparents of Catherine Eyre, wife of Rev. Charles¹ Chauncey, second president of Harvard College. [127] Thomas Alabaster's mother-in-law, Dorothy (Forth) Warren, was the great-great aunt of Mary Forth, the first wife of Governor John¹ Winthrop. [128]

Thomas Lawrence was of South Elmham in 1594 and 1595, when mentioned in the Dedham Hall court records given above, and of Easthorpe, Essex, in 1610 when named in the will of his brother-in-law, Henry Sherman.

The children of Thomas and Priscilla (Alabaster) Lawrence have not been identified. The children of Thomas and Mirable (\_\_\_\_) Lawrence, all baptized at St. James, South Elmham, were:

She married in Moze, Essex, 14 June 1568, HENRY SHERMAN the younger, born say 1545, probably in Dedham, died between 21 August and 31 August 1610 (dates of his will and his widow's will), son of Henry Sherman the elder and his first wife. In his will dated 21 August 1610, proved 8 September 1610, [129] Henry Sherman, clothier, of Dedham named wife Susan; sons Henry, Nathaniel, Daniel, John, Ezekiel, and Edmund; son Samuel Sherman; [130] cousin Edmund Gallaway; [131]

Mr. Rogers, preacher of Dedham; the poor of Dedham; daughter Phebe Fenn [widow of "son-in-law Simon Fenn deceased," and mother of "Henry Fenn, son of Simon Fenn"]; daughters-in-law, "each of them"; Anna Petfield, daughter of William Petfield; "Anne Sherman, my brother Dr. Sherman's daughter" [he evidently deceased]; brother-in-law Gilbert Hills; brother Lawrence of Easthorpe. Wife Susan was to be sole executrix, and cousin Edmund Gallaway, clerk, was to be supervisor.

Susan Sherman, widow, made a will dated 31 August 1610, proved 12 September 1610, [132] naming sons Harry, Samuel, Daniel, Nathaniel, John, Ezekiel, and Edmund; daughters Phebe Fenne and Anne Whighting; son Daniel's wife; son Nathaniel's wife; Robert Salmon's son "my great grandchild"; Mary and Susan Sherman, daughters of son Samuel; brother "Gilber Hilles"; Mr. Rogers; Susan Galloway, daughter of cousin Edmund Galloway. Son Henry was to be sole executor.

He was the son of Gilbert and Agnes (Sammes) Hills (see John Lawrence [No. 3], who married Anne Sammes, sister of Agnes).

Although the children of Gilbert and \_\_\_\_\_ (Lawrence) Hills have not been identified, a son was probably Gilbert Hills of Dedham, who had five children baptized there between 1610 and 1616, and who in 1628 was a tenant of Anthony Whiting (see No. 12).

9. JOHN LAWRENCE (3.vi) of St. James Park, South Elmham, Suffolk, was born by 1560, as he was aged 50 and more at his father's death in 1610, according to his father's *inquisition post mortem*. He married ELIZABETH HERNE, daughter of William Herne of Tibbenham Long Row, Norfolk, by his third wife Elizabeth

England [note 49], 2:1170. Nathaniel Sherman did not have a sister who married John (or any other) Anger, this John Anger's wife being Nathaniel's first cousin. John Anger did not have a sister Priscilla, the name of Nathaniel's second wife, but did have a sister Phebe, otherwise unaccounted for — and Phebe was the name of Nathaniel's first wife (known from her burial record). In his will Nathaniel entrusted his son Nathaniel's legacy to John "Ainger," who thus was the son's own uncle.

He married about 1598 PHILLIPP WARD, 149 born say 1575, daughter of Lancelot and Joan (\_\_\_\_\_) Ward of Wethersfield, Essex. Phillipp died after 8 January 1616[/7], when she witnessed the will of her brother, Robert Ward. 151]

John<sup>1</sup> Ward of Ipswich, Massachusetts, a great-nephew of Phillipp (Ward) Sherman,<sup>[152]</sup> left a will dated 26 December 1652, proved 25 March 1656,<sup>[153]</sup> mentioning the two youngest sons of cousin Samuel Sherman of Boston, deceased and cousin Philip Sherman of Rhode Island.<sup>[154]</sup>

Samuel Sherman's 1615/6 will mentions wife Phillipp; sons (all under 22) Henry, Phillipp, and Samuel; daughters Mary and Martha (both under 21). Executors were to be wife and Mr. John "Upcheire" of Dedham, "my brother in law."

She married second Thomas Wilson of Dedham, butcher, who died between 30 January 1630[/1] and 24 May 1631 (dates of will and probate). [158]

In his 1628 will Anthony Whiting of Dedham, clothier, mentioned (among others) wife Anne; son Simon Whiting; son Anthony Whiting and his wife Mary; daughter Phebe; son John; daughter Susan Whiting; brothers Henry and Ezekiel Sherman; daughter Anne Loveran; the poor of Dedham and Stanway.

In his 1631 will Thomas Wilson of Dedham butcher, mentioned (among others) wife Anne; "Mr. Anthony Whiting, Phebe Whiting, and the rest of my wife's children." Brother-in-law Henry Sherman senior was to be an executor.

In her 1638 will Anne Wilson of Dedham, widow, mentioned son Anthony Whiting of Bentley; son John Whiting and his daughter Anne; daughter Susan Cole; daughter Phebe Bernard of New England and "her two children born here before she went over, viz<sup>t</sup> John and Samuel;" nephew Simon Whiting (under 21), son of son Simon Whiting deceased; Jane Whiting (under 21), daughter of said son Simon; two nephews Anthony and Thomas, sons of son Anthony Whiting; brother Edmund Sherman; brother Ezekiel Sherman (to be sole executor).

- i. SUSAN SHERMAN, b. say 1602; m. JOHN BURR, b. ca. 1602, eldest son of Henry and Ann (Fisher) Burr of Stisted, Essex. John's younger brothers were Henry Burr and Simon Burr, both of whom settled in Hingham, Mass. Their mother Ann was an aunt of Mary Fisher who married Henry Sherman [No. 17]. [168]
- ii. EDMUND SHERMAN, bp. Dedham 16 Dec. 1604; d. after 1 April 1633 (date of father's will) but not in brother John's 1658 will. [169]
- iii. (REV.) JOHN SHERMAN, b. say 1606. As John Sherman of Norwich, clerk, he left a will dated 6 July 1658, proved 20 July 1661, [170] naming half sisters Christian Sherman and Martha Davie; brother Bur "who married my sister Susan Sherman"; sister Sherman "my brother Daniel's widow, being executrix"; children of half sister Mary Alexander; "two children [unnamed] of my uncle Edmond Sherman" [No. 15]; and brother Henry Sherman (to be executor). - x. MARTHA SHERMAN, b. say 1631; d. after 6 July 1658, the date of her brother John's will; m. Colchester (recorded in Dedham) 19 Sept. 1656 HENRY DAVY.
- 14. JOHN SHERMAN (7.viii) was baptized in Dedham, Essex, 17 August 1585, and was buried in Great Horkesley, Essex, 24 January 1615/6. He married in Wattisfield, Suffolk, 26 September 1611, GRACE RAVENS, born say 1591, probably in East Bergholt, Suffolk, daughter of Rev. Richard and Elizabeth (Hedge) Ravens. Grace married second by 1617 Thomas Rogers, with whom she

immigrated to New England in 1634. He was buried in Watertown, Massachusetts, 12 November 1638, and she married third Roger<sup>1</sup> Porter. [172]

Grace died in Watertown 3 June 1662, leaving an undated will proved 17 June 1662, naming daughter Elisabeth [Rogers] Smith and her son Daniel Smith; son John Sherman and his children John, Martha, Mary, Sarah, and Joseph. "My cousin" John Sherman was to be overseer. When the will was proved, Grace had a son living in England, but where, and whether he married and had a family, are not known. [173]

15. EDMUND SHERMAN (7.x) was born say 1589, and was buried at St. James, Colchester, Essex, 2 September 1661. He married in Dedham, Essex, 15 May 1611, JUDITH ANGER/ANGIER, baptized in Dedham 5 June 1587, daughter of William and Ann (Rye) Anger. There is a widespread misconception that this couple had descendants in New England. [177]

The 1658 will of Rev. John Sherman [No. 13.iii above] mentioned "the two children of uncle Edmond Sherman," but did not name them. The nuncupative will of Edmund Sherman of Colchester St. James, webster, made in August 1661, was proved in Colchester 14 October 1661 by Edmund Sherman, described in the will as his "only child, the sole executor," to whom he left "all his goods and estate whatsoever." These two wills taken together suggest that the testator's last surviving daughter died between 1658 and 1661, unless he had disowned her.

### 1613 Inquisition Post Mortem of John Lawrence: Suffolk [180]

[Entered above the main text]: It was handed over to the Court on the 21st day of October in the eleventh year of King James of England, etc. [1613], by the hands of Henry Barker below written.

Inquisition indented taken at Bury St Edmunds in the said County the third day of August in the eleventh year of King James in England and forty-seventh in Scotland [1613], before Thomas Wingfeild esq, feodary of the said County, Henry Goldsmythe esq, Francis Choppyn gent and Robert Burham esq, escheators of the said County by virtue of a commission in the nature of a brief of mandamus of the lord king directed after the death of John Lawrence gent deceased to the same commissioners and others, and is attached to this inquisition, by the oath of Thomas Offwood, Thomas Smyth, Thomas Strutt, John Darby, William Stafford, Thomas Vyncent, Thomas Ellys, William Rosse, William Tiptot, John Garneham, Mark Corbold, George Hasell and William Rushbrooke, upright and lawful men of the said County, Who say upon their oath that the said John Lawrence named in the said commission the day before his death was seized in his demesne as of fee of and in two messuages situated near Fressingfeild Church in the said County with all and singular the houses, lands, barns, stables, buildings, orchards, gardens, hearths, easements and commodities whatsoever with all and singular their appurtenances reputed, had or known as part, parcel or member of the said messuages, or in any way whatsoever belonging or pertaining to the same in Fressingfeild, And of and in fifty seven acres of meadow and pasture adjoining or pertaining to the said messuage, lying and being in Fressingfeild as now divided into several parts, And also of and in two other pastures or closes, one of which is called Nethercarterfeild and the other is called Seven Acres and Ovyeland as now divided into several parts, containing by estimation twenty two acres more or less lying in Fressingfeild, And also of and in two other closes, meadows and pastures, one of which is called Coweclose and the other is called Edwards Hill as now divided into several parts, containing by estimation thirty two acres more or less likewise lying in Fressingfeild, with all and singular their appurtenances, And of and in half an acre and one rod of land formerly parcel of the Rectory of Fressingfeild with the appurtenances in Fressingfeild, All and singular which premises were formerly of Simon Toppesfeild gent and called Toppesfeilds, and being so seized of all and singular the said premises called Toppesfeilds, the same John Lawrence by his charter, enfeoffed a certain William Rose and Phillip Calthorpe to have and to hold the said premises called Toppesfeilds with the appurtenances to the same William Rose and Phillip Calthorpe and their heirs forever upon trust and confidence for the benefit and commodity of the said John Lawrence and his heirs, by virtue of which the
